RISK MANAGEMENT

- » Continued updating of the Risk Management Toolkit with incorporation of the NIST Cybersecurity Framework (NIST CSF)
- » Our workgroup members enjoyed sharing and discussing the variety of news stories dealing with information security, threats, vulnerabilities, alerts, critical patches, as well as COVID-19

- » Continued to hold meetings during the year
- » Continued to review and update policies
- » Identified and shared with workgroup updates related to Cybersecurity from regulatory bodies to maintain up to date body of knowledge

- » Discussed implementation of Multi Factor Authentication in work environment

COVID-19

- » Continued meeting throughout the year on first Tuesday of every month
- » Continued to provide an open forum to participants to discuss the everchanging challenges of COVID-19 at work and in our personal lives
- » Began discussing general HIPAA and healthcare topics in addition to COVID-19

PRIVACY

- » Review and finalize privacy deliverables identified by Information Blocking Workgroup related to interoperability and information blocking
- » Facilitate quarterly Privacy Networking calls as open forum discussions
- » Present a webinar on current privacy topic -TBD
- » Participate in developing privacy curriculum for HIPAA COW Spring and Fall conferences

RISK MANAGEMENT

- » Continue to update, improve, and maintain the Risk Analysis and Risk Management Toolkit:
 - » Finish incorporating the NIST Cybersecurity Framework into the Risk Management Toolkit
 - » Continue to share current topics and discuss how to manage threats and vulnerabilities
 - » Recommend risk topics for sessions at HIPAA COW conferences
 - » Recruit IT / security experts to the Risk Management Networking Group
 - » Evaluate new features from the OCR and ONC updated Security Risk Assessment Tool for inclusion into the Risk Toolkit

SECURITY

- » Create more structure for meetings and greater content value by improved scheduling and organization by the co-chairs
- » Organize members by specialty/interest areas to help identify and drive greater breadth of topics for discussion
- » Continue to review and revise policies and procedures as part of the ongoing policy updating procedure
- » Work with members to identify trends in the HIPAA Security space for further review or more intensive discussions
- » Prepare to identify how processes in the Security space may be affected by the HIPAA Final Rule expected to be published in March 2023
- » Greater use of tools to better connect the NG membership to include exploring communication sharing between meetings using available tools (shared online folders, chat, email)

HEALTHCARE IT

- » Continue member growth and participate
- » Share information on healthcare IT issues affecting group members
- » Develop additional resources for sharing important information

COVID-19

- » Convert to new Moo and Chew Networking Group
- » Finish sending updated communications about this new networking group and recruiting people to sign up to the group
- » Send emails one week before each call requesting participants to send before, or bring to the calls, topics to discuss
- » Freely discuss and share knowledge about a variety of HIPAA, health, and other organization operations-related topics
