- » Facilitated quarterly Privacy Networking calls as open forum discussions
- » Participated in developing privacy curriculum for HIPAA COW Spring and Fall conferences

SECURITY

- » Increase average attendance at monthly meetings by 20%
- » Continue to update policies in reverse chronological order with oldest policies getting updated first
- » Identify and share with workgroup updates related to Cybersecurity from regulatory bodies to maintain up to date body of knowledge
- » Continue to hold meetings as regularly scheduled without any unexpected postponements

RISK MANAGEMENT

- » Continued updating of the Risk Management Toolkit with incorporation of the NIST Cybersecurity Framework (NIST CSF)

- » The RMNG also hosted lively discussions of how the COVID-19 pandemic is impacting risk management in our organizations and industry

HEALTHCARE IT

- » Working on our first deliverable on how to vet out new systems coming into your network
- » Discussions included:
 - » How Cyber Insurance has started driving security needs of the organization
 - » Managed Detect and Response systems and Risk Vulnerability assessments
 - » Implementation of Multi Factor Authentication

COVID-19

- » Successfully transitioned the calls to the first Tuesday of every month
- » Continue to provide an open forum to participants to discuss the everchanging challenges of COVID-19 at work and in our personal lives
- » Grew the average number of monthly participants to over 30

PRIVACY

- » Review and update at least four privacy deliverables related to information blocking
- » Facilitate quarterly Privacy Networking calls as open forum discussions
- » Present a webinar on current privacy topic -TBD
- » Participate in developing privacy curriculum for HIPAA COW Spring and Fall conferences
- » Convene the Information Blocking Workgroup to identify and create deliverables related to the implementation of the 2022 regulations

SECURITY

- » Gain increased participation amongst members in regular meetings, policy/document review, etc
- » Collaborate with strategic partners on sharing trends and issues to our membership
- » Identify current trends and issues related to HIPAA Security
- » Conducted regularly scheduled meetings throughout the year
- » Discuss/shared strategies to mitigate risks related to HIPAA Security

- » Provide an open forum for members to share insights, ideas, and comments on hot topics and enforcement activities
- » Update policies and documents assigned to the Security Networking Group

RISK MANAGEMENT

 - » Finish incorporating the NIST Cybersecurity Framework into the Risk Management Toolkit
 - » Continue to share current topics and discuss how to manage threats and vulnerabilities
 - » Evaluate new features from the OCR and ONC updated Security Risk Assessment Tool for inclusion into the Risk Toolkit

HEALTHCARE IT

- » Host webinar on hot topics affecting group members
- » Continue member growth and participate
- » Develop additional resources for sharing important information (IE: Bulletins, Security Alerts, etc.)

COVID-19

- » Continue providing an open forum to participants to discuss the everchanging challenges of COVID-19
- » Continue to hold the calls on a monthly basis, unless participants recommend more or less
- » Determine if this concept/networking group should remain for as long as COVID is relevant (as previously planned), or if there is a need for a simple, open forum to discuss anything/everything in a larger, more collaborative setting. The HIPAA COW website, hipaacow.org, has been a resource to thousands of users. For the 12 months ended September 30, 2021, there were nearly 15,000 users of the site, making almost 21,000 visits. Of those 21,000 visits, over 7,000 originated from Wisconsin users, over 11,000 from other states, and the rest came from throughout the world. There were users from every state in the United States.

The site provides a wealth of information about HIPAA with free access to HIPAA COW deliverables. Users of the website can find information on HIPAA COW and sponsored events, numerous documents related to Privacy and Security issues, presentations on HIPAA, a job board, links to other related websites, and other useful information.

Interest in HIPAA COW conferences drew many visitors, resulting in over 500 registrations at our two virtual conferences this past year. Conference materials can be found on the website.

Many visitors download documents and other resources that are also available on the website. The “Risk Tool Kit” and “HIPAA 101” were the most accessed documents during the year. HIPAA COW does not charge any fees for using the resources available on the website.
